<b>Conditions for safe storage</b>	Place the handle back into the handle rest after use. Do not pull on the handle when the WaterRower is upright – this can cause the WaterRower to fall over. When the WaterRower is in its upright storage position, take care it is not bumped which may cause it to fall over. Take extra caution with children.
<b>Incompatible materials</b>	Do not use chemical cleaners of any kind on the rower's tank as it may damage the polycarbonate tank material.  Do not use methylated spirits, ammonia-based fluids, chlorates, or bleach when cleaning any part of the rower.
